#### **Helpful Tip!**

Students MUST report their name exactly as it appears on their social security card. This includes hyphenated names.

## PARENT CHECKLIST

Students are required to report parent information on the FAFSA. For reporting purposes, "PARENT" refers to your legal (biological or adoptive) parent or stepparent, or a person that the state has determined to be your legal parent. Students who are Foster Youth, Homeless or have children of their own, DO NOT need to report parent info on the FAFSA.

To save time, use the "IRS Data Retrieval" tool within the FAFSA application to upload your 2018 tax information directly into the FAFSA.

#### \*Parents who do not have a SSN cannot create an FSA ID. They must sign and mail the signature page provided at the end of the FAFSA application.

### IF PARENTS ARE DIVORCED/SEPARATED:

Students must report the parent they lived with the most over the past 12 months and provide the above information. You will also need to know the month & year of the divorce/separation. If the parent re-married, you will also need to provide the same information for the step-parent.

### IF PARENTS ARE DIVORCED & YOU SPLIT TIME EQUALLY BETWEEN BOTH:

Students must provide the Social Security #, birth date and full name for the parent who provided the most financial support over the past 12 months, as well as their spouses information if re-married.
