## **Electronic Information Resource Contract**

New technologies are modifying the ways that information may be accessed, communicated, and transferred. Those changes may also alter instruction and student learning. EDUHSD offers students access to technologies that may include electronic mail, Internet connections, and equipment, such as computers and multimedia hardware in the technology labs, video production, library, and classrooms.

Along with access to computers and people all over the world comes the availability of materials that may not be considered appropriate in the classroom. However, on a global network it is impossible to control all materials. Ultimately, the school staff, parents and guardians of minors are responsible for setting and conveying the standards that students should follow when using media and information sources. EDUHSD supports and respects each family's right to decide whether or not to allow their student access to any part of these technologies.

In order to comply with the Children's Internet Protection Act, in 2001 the District implemented an Internet "filtering" system to reduce access to materials harmful to children. Sites blocked are generally those that contain or promote pornographic or obscene material; criminal activities; gambling; chat rooms and dating; and violence. However, parents and guardians should be aware that in a growing and ever-changing Internet environment, this blocking mechanism can never be 100% effective.

#### **TECHNOLOGY USE RULES AND RESPONSIBILITIES**

The school code of conduct, district rules and regulations along with policies and procedures, and local, state and federal laws govern access to and use of media technology. Students will be held accountable for any misuse or abuse of any school material.

The technologies provided are for students to conduct research, enrich educational experiences, and communicate with others in relation to school work. Access to technological services is given to students who agree to act in a considerate and responsible manner. Parent permission is required. Access is a privilege, not a right. Therefore, based upon the acceptable use guidelines outlined in this document, the system administrators will deem what is inappropriate use and their decisions are final. The administration, faculty, and staff of each school may deny, revoke, or suspend specific user privileges.

Individual users are responsible for their use of technologies. The use of these tools must be in support of education and research and must be consistent with academic expectations of the school. Use of other organizations/networks or computing resources must comply with the rules appropriate for that network. Transmission of any material in violation of U.S. or state regulations including copyrighted, threatening, or obscene materials is prohibited. Use for commercial activities by for-profit organizations, product promotion, political lobbying, or illegal activities is strictly prohibited.

The district may establish and maintain Web sites. The school principal will designate an individual to be responsible for managing the school Web site and will establish a process and criteria for the posting of material on the school and class Web pages. Images/pictures of students or individual student work may be posted on the district, school, or class Web sites only after obtaining parent permission.

The user is expected to abide by the following rules of etiquette:

- Be polite. Do not write or send abusive messages.
- Use appropriate language. Do not swear, use vulgarities or any other inappropriate language.
- Transmission of obscene materials is prohibited. Sending or receiving offensive messages or pictures from any source will result in immediate suspension of privileges.
- Do not reveal the personal address or phone number of yourself or other students.
- Do not communicate any credit card number, bank account number, or any other financial information.
- Electronic mail is not guaranteed to be private. People who operate the system do have access to all mail. Inappropriate messages can result in suspension of privileges.
- Do not use the network in a way that would disrupt the use of the network by other users.
- Vandalism—any malicious attempt to harm or destroy data or equipment—will not be tolerated. Any questionable action will result in the cancellation of user privileges.
- Use of personal data or equipment will not be allowed without prior approval.
- Report any misuse of the network to the system administrator.

Violation of any of the above mentioned rules and responsibilities will result in a loss of access and may result in other disciplinary or legal actions.
