



THE EL DORADO UNION HIGH SCHOOL DISTRICT'S BOARD POLICY PROHIBITS, AT ANY DISTRICT SCHOOL OR SCHOOL ACTIVITY, UNLAWFUL DISCRIMINATION, HARRASSMENT, INTIMIDATION AND BULLYING OF ANY STUDENT BASED ON THE STUDENT'S ACTUAL RACE, COLOR, ANCESTRY, NATIONAL ORIGIN, ETHNIC GROUP INDENTIFICATION, AGE, RELIGION, MARITAL OR PARENTAL STATUS, PHYSICAL OR MENTAL DISABILITY, SEX, SEXUAL ORIENTATION, GENDER, GENDER IDENTITY, OR GENDER EXPRESSION; THE PERCEPTION OF ONE OR MORE OF SUCH CHARACTERISTICS; OR ASSOCIATION WITH A PERSON OR GROUP WITH ONE OR MORE OF THESE ACTUAL OR PERCEIVED CHARACTERISTICS.

THE DISTRICT ALSO PROHIBITS ANY FORM OF RETALIATION AGAINST ANY STUDENT WHO FILES A COMPLAINT OR REPORT REGARDING AN INCIDENT OF DISCRIMINATION, HARASSMENT, INTIMIDATION, OR BULLYING.

IF IT HAPPENS REPORT IT: ANY STUDENT WHO FEELS HE/SHE HAS BEEN SUBJECTED TO DISCRIMINATION, HARASSMENT, INTIMIDATION, OR BULLYING SHOULD IMMEDIATELY REPORT IT TO SCHOOL ADMINISTRATION OR ANY OTHER STAFF MEMBER. ANY STUDENT OR SCHOOL EMPLOYEE WHO OBSERVES AN INCIDENT OF DISCRIMIN ATION, HARASSMENT, INTIMIDATION, OR BULLYING SHOULD REPORT IT TO SCHOOL ADMINISTRATION, WHETHER OR NOT THE VICTIM FILES A COMPLAINT.

CONSEQUENCES: STUDENTS WHO ENGAGE IN DISCRIMINATION, HARASSMENT, INTIMIDATION, OR BULLYING SHALL BE SUBJECTED TO APPROPRIATE DISCIPLINE UP TO AND INCLUDING COUNSELING, SUSPENSION, AND/OR EXPULSION. AN EMPLOYEE WHO PERMITS OR ENGAGES IN PROHIBITED DISCRIMINATION, HARASSMENT, INTIMIDATION, OR BULLYING SHALL BE SUBJECT TO DISCIPLINARY ACTION, UP TO AND INCLUDING DISMISSAL.

#### **Parent Square**

Parent Square (PS) is a two-way private communication platform. It provides a safe way for administrators, teachers, staff, groups and parents, to connect and effectively communicate. All school, grade level and classroom information is sent from one centralized place to your computer or mobile phone via email and/or text or you can download the FREE app! It is important for all current PS users to verify that your AERIES information is correct since PS pulls your contact information from AERIES. Enrollment in PS is automatic, we recommend that you register for PS by accepting the invitation from PS when you receive it. *\*If you haven't received an invitation send an email to cgarrett@eduhsd.k12.ca.us, use the subject line "Parent Square". Include your name, email address and student name. Please look for an invitation email to join Parent Square. Click the link to activate your account and register.* 

#### **Daily Bulletin**

The daily bulletin is the official means of communicating school information to all students and staff. All activities, athletic events, meeting dates, club news, teacher news, scholarship information and special schedules, etc., are published each day. #### Messages

When classes are in progress, phone messages will only be delivered in case of a serious family emergency. This is in adherence to the School Board's directive to not interrupt the instructional process. We discourage the delivery of items for students at school such as: balloons, flowers, lunches, etc. If necessary, items may be dropped off from parents to the main office; parents may text their student to come and pick up during lunch, breaks, or passing periods.

# **Campus Loitering**

Students are not allowed to loiter (hang out) in the bus circle, in front of the school, or in the lower or upper parking lots before school, during passing, or lunch. Other areas that are banned from student loitering include property and streets that adjoin the school. Students are allowed in the quads, cafeteria, multi-purpose room, and library during lunch.

### Deliveries

No food deliveries are allowed: No grub hub, no uber eats, no doordash, no pizza delivery or any other food delivery services. It will be turned away and items will be sent back with the driver.

#### Associated Student Body Message

We believe the creation of a positive school climate, "STARTS WITH YOU!" When you see something that is wrong - bullying, littering, cheating, etc. - say something to stop it. If you see something good being done, say something to that person. If you have the strength to lead, you can make a great difference in our school. We can affect more change if students take charge as the leaders on the campus. Step up and help make El Dorado a great place! We have an anonymous reporting app called STOPit that you can use to report.

### Student Government – ASB

The El Dorado High School Associated Student Government is maintained through the active support of the students by authority of the Principal and Board of Trustees. The ASB organizes student activities, regulates student body funds, and advises the administration on policies affecting students. The ASB constitution was written and revised by students for the purpose of serving the entire student body.

### Students Clubs, Activities, and Organizations

**GET INVOLVED**...There are many different types of student activities aimed at meeting every student's interests, such as: Key Club, California Scholarship Federation (CSF), Yearbook, Faith Out Loud, Choir, Drama Club, Academic Decathlon (competitive academics), Multi-cultural Club, Speech and Debate, Interact Club, Manos a la Obra, Natural Resource Club, Circuit Breakers Robotics Team, Health Academy, EDHS Litterarum Club, Athletics, Cheerleading and Student Government. A complete list of clubs and their descriptions are available in the counseling office and on our school website.

### Academic Letter and Student Recognition

In recognition of academic success, students who earn a 3.5 or better for three consecutive semesters will receive an academic letter. This ceremony takes place once per year. Students with outstanding attendance will also receive a certificate.

### **Textbooks and Equipment**

Students are financially responsible for any books and materials issued to them. If paying for a lost or stolen book, make sure you get a receipt. No diploma will be issued to graduating seniors, nor will students be permitted to participate in athletics and the three major dances, until all debts are cleared.

#### Life Fitness Uniform Policy

Students are expected to wear their life fitness uniforms every day they have class. If a student does not bring his or her uniform, he or she will be provided a "loaner" uniform from the life fitness staff up to 3 times. If a student refuses a loaner uniform, he or she will be considered defiant and will be referred to the administration for disciplinary action.

#### Transportation

Most El Dorado High School students ride buses at some time during the school year, either to or from school or with athletics, field trips, or other school activities. The number one priority for the Transportation Department is to ensure the safety of all passengers. Therefore, orderly conduct is expected at all times and everyone aboard is to follow the directions of the driver. Remember, all school rules apply on the bus and at the bus stop. Violators of the bus rules are subject to disciplinary action, which may include the DENIAL of transportation. Semester bus passes may be purchased at the District Transportation office or in the Finance Office in the Administration Offices. Daily bus trip passes are available at school from the finance office. #### **Parking and Driving Regulations**

Students who drive to school are advised that all provisions of the California Vehicle Code are strictly enforced. **Parking is limited and available on a first-come first-served basis.** If you have a circumstance that requires special consideration, please contact your assistant principal. Citations will be issued to vehicles improperly parked or vehicles in the faculty/reserved lots. Students who violate parking lot and driving regulations will be subject to discipline consequences and/or loss of parking privileges. **Students are not permitted to loiter (hang out) in the parking lots.** The school assumes no responsibility or liability for theft or damage to cars, motorcycles, or bicycles. At no time are cars, trucks, bicycles, etc., to be driven on sidewalks, lawns, athletic areas or any area NOT designated for vehicle traffic. **The parking lots are off limits during school hours.** You must also be advised that school administrators with reasonable cause may inspect vehicles on campus at any time.

#### **Skateboards and Scooters**

These items should not to be brought to school and are not allowed to be ridden on campus at any time. They often cause campus and class disruption and are frequently misplaced or stolen. If they are brought to school, they must be stored in a classroom or office. The school will not investigate or participate in attempts to recover such lost or stolen items.

### **ID Cards and ASB Cards**

All students will have access to a digital ID card, which can be accessed on a cell phone or other digital device. Students may request a physical ID card at no charge. Defacing or losing the card will result in a fine to cover the cost of replacement. Students are expected to carry a digital or physical ID card on campus at all times and be prepared to present it at the request of any staff member. ID cards (physical or digital) are necessary to check out books and materials from the library, to leave campus during unscheduled periods (with appropriate sticker for unscheduled 6<sup>th</sup> and 7<sup>th</sup>), to be admitted to any EDHS-sponsored dance, athletic events or activity, and to ride busses.

Students who purchase an ASB card will have their ID card specially marked. The activity ID entitles a student to significant discounts on most school activities. Money derived from the sale of ASB cards goes to support all schoolsponsored activities.

### **Campus and Classroom Conduct**

In general, problems that are of a basic classroom nature - tardiness, violation of class rules, non-participation, lack of effort, and poor academic progress - will be handled by the teacher. Continued problems of this nature will be referred to the appropriate Assistant Principal or Dean. <u>Students should be aware that all school rules and regulations apply while coming to school, going home from school, as well as during all school activities. This includes: the parking lots, inside student vehicles, and student lockers.</u>

### Lockers

Lockers will be assigned to students who are in life fitness. Please remember, the school does not assume responsibility for loss or damage to the contents of lockers. We do, however, ask that you report any problems (vandalism, theft etc.) to the assistant principals' office AT ONCE. Be advised that school administrators may inspect lockers at any time with reasonable suspicion.

When students need to go to the Health Office they must first obtain a pass from their teacher (except for emergencies).

- 1. Students must check-in with the health technician immediately upon arrival.
- 2. Parents will be contacted by school staff if a student is ill or injured and must go home.
- 3. Under **NO CIRCUMSTANCES** is a student permitted to leave campus without authorization.

#### Medications

If students must take medication during school hours, a *Medication-In-School* form must be signed by a doctor and the student's parent/guardian and returned to the health tech at El Dorado High School. This includes over-thecounter medications and prescription medicines, including emergency medications such as inhalers and Epi-pens. The medicine must be brought to school in the prescription labeled original container and over the counter medications in the original container. The medicine is kept in a locked cabinet and the student must come to the health office to obtain the medication. #### **Emergency Contacts**

#### **Counseling and Guidance Services**

The El Dorado High School counseling/guidance/career staff is committed to assisting all students. This includes academic, career development, and personal/social domains. Students and parents are encouraged to contact the counseling office to meet with their student's counselor.

#### **Work Permits**

California State Law requires that:

- 1. All minors under 18 years of age must have a work permit issued by the school <u>before</u> being employed.
- 2. Work permit applications may be obtained in the College and Career Center. These permits are issued pending verification of <u>regular school</u> <u>attendance</u>.
- 3. Students must be eligible (2.0 GPA) to have and maintain a work permit.

### **FLEX Time Schedule**

Flex Time is an enrichment and recovery period. We will offer students four Flex Time periods every week where they can select offerings that are curricular or co-curricular in nature. Flex Time will be 41 minutes long following first to allow for suiting out, performances, and labs while balancing our regular periods. Teachers will post their Flex Time offerings on Flexisched the week before students will be selecting their offerings. Students will be able to select and change where they are going to during Flex Time up until 5 minutes before the Flex Time period, unless they have been assigned an offering by a teacher. Departments will choose what they are offing to students via Flexisched, and students will have a choice from skill remediation (or re-teaching), make-ups, study hall, or enrichment. Flex Time is a period that students must attend and will be marked present or absent for. It is our hope that Flex Time brings more choice, flexibility, and meaningful contact between all members of campus.

# Where do I go if I don't sign up for Flex Time?

You can sign up for Flex Time on the school website. You can also go directly to our flexisched website. Do NOT search for flexisched on google; you will most likely get a different school's flexisched website.

### What happens if I don't sign up for a Flex Time?

If you don't sign up for Flex Time, you will be put into a Flex Time detention for the Flex Time period where you will receive a lunch time detention for that day.

### Attendance Procedures ATTENDANCE OFFICE - 622-3634, ext. 1011

**\*\*EDHS IS A CLOSED CAMPUS** - once a student arrives on campus, he/she must stay. **Students must secure a pass from the attendance office before leaving campus for any reason.** If your student needs to be checked out during the day, please send a note with the student in the morning. The signed note (in ink) from the parent/guardian must include the student's full name, the reason for the absence(s) and the date(s). **Failure to secure a pass from attendance will result in detention.** 

If for some reason you are not able to send a note with your student, please call the attendance office for a pass and allow **15-30 minutes for the pass to be processed**. Please be advised that passes will not be delivered the last 15 minutes of the school day for early release. **Passes are not delivered during finals, AP testing, and state testing. Please plan in advance.** If they are returning to campus they must check back in with attendance to secure a return to class pass.

All notes and phone calls to clear absences must be received within **3 days of the absence** or disciplinary action will be taken. Detentions will be assigned for failure to checkout with the attendance office.

Parents/guardians should call the Attendance Office if their student will be absent and the reason for the absence. This line is available for attendance messages **24 hours a day**.

Valid excuses for absences include: verified illness of the student, medical, dental, or optical services, school-sponsored educational trips, quarantine, and bereavement in the immediate family. Vacation or out of town trips are considered unexcused absences.

Students with excused absences will work with their teachers to make up their work in an agreed upon time. It is the student's responsibility to contact their teachers for assignments. If you need assistance collecting assignments, please contact the counseling office.

### **Truancy Policy**

Truancy will result in detentions/Progressive Discipline. Habitual truancy will result in progressive discipline action from assistant principals and referral to the School Attendance Review Board (SARB).

# **Tardy Policy**

Students are expected to be in class and in their assigned seats when the tardy bell rings. Teachers will enforce tardy policies within their classrooms.

#### Violations across all classes:

- 5 Tardies = 1 Detention\*
- 10 Tardies = Administrative conference and 3 Detentions
- 15 Tardies = Saturday School
- Continued tardiness will result in progressive discipline for defiance and may be referred to the Student Attendance Review Board (SARB) and Social Probation. Students and parents may access attendance records by logging onto their Aeries accounts.

\*Teachers may utilize classroom interventions and student/parent conference as necessary.

#### Late Policy

For the first class of the day students are expected to be in class and in their assigned seat when the tardy bell rings. If students are not in their seats the following consequences occur:

### CONSEQUENCES

- Students who are tardy within 10 minutes of the tardy bell ringing should report directly to class and will receive a tardy. They should NOT report to the office.
- Students who are over 10 minutes late should report to the main office to check in and will receive 1 detention.

### School Sponsored Activities Expectations and Conduct

All rules and regulations governing student conduct at school also apply to all school and District sponsored events, athletic contests, proms, dances, plays, banquets, field trips, etc., whether held on or off campus, before, during, or after school.

### **School Discipline Policies**

The following offenses will result in detention, suspension, transfer to another School/Program or Expulsion from the district (possible referral to an outside agency, i.e. law enforcement):

#### Violations Requiring Recommendation for Expulsion:

Under state law and Board of Education Policy, El Dorado High School is compelled to recommend expulsion for:

- Possessing, selling or furnishing a firearm
- Brandishing a knife
- Unlawfully selling a controlled substance
- Possession of Explosives
- Committing or attempting to commit sexual assault

# **Other School Discipline Violations**

### **Violations against Persons**

- Assault/fighting and/or battery
- Weapons or other dangerous objects (any knife)
- Hazing, harassment (includes sexual harassment)
- Interference/obstruction of staff member
- Verbal abuse, racial or ethnic slurs
- Defiance of authority

### **Violations Involving Property**

- Theft or Robbery
- Extortion/attempted extortion
- Unauthorized use of school property or damage to school property

# Violations against Public Decency and Good Morals

- Gambling (games of chance with stakes)
- Acts of vulgarity/profanity
- Offensive social behavior

# Violations against Public Health and Safety

- Possession/use of illegal substances, i.e. alcohol, drugs
- Possession of illegal paraphernalia
- Misrepresentation/sale/delivery/furnish a controlled substance
- Nicotine-possession

Devices such as vapes, e-cigarettes, electronic pens, vaporizers, which are made and/or used for inhaling tobacco, can potentially be used as drug paraphernalia. These items are prohibited on El Dorado Union High School District property and school campuses. Appropriate disciplinary action will be administered up to and including suspension/expulsion for students who possess such items. Consequences can include recommended counseling services.

#### **Miscellaneous Violations**

- Disruptive behavior
- Forgery and dishonesty
- Distribution of obscene, libelous, slanderous literature
- Gang related activity
- Misbehavior on school bus
- Violation of suspension rules
- Unauthorized visiting of other campus

#### **Fire Code Violations**

- False alarm
- Lighting a fire/pyrotechnics (fireworks or firecrackers)
- Blocking a marked fire lane

#### Harassment, Sexual Harassment, and Terrorist Threat

No students shall engage in harassing behavior, sexual or otherwise, toward another student or staff member. Harassment includes willful engagement in unwelcome verbal or physical behavior that creates a hostile environment for another person or group of people. Included, but not limited to: words, touching, gestures, notes, pictures, signs, posturing, or any other behavior that creates a hostile or threatening environment.

### **Social Probation**

Students will be placed on 30 instructional days (possible 20 days with good behavior) of social probation for infractions including, **but not limited to:** 

- A suspension for three or more consecutive days
- Fighting; possession and/or under the influence of a controlled substance, alcoholic beverage, or dangerous substance
- Repeated acts of defiance
- Accumulation of excessive tardies

Social probation sanctions will be implemented for **30 days** (possible 20 days with good behavior) instructional days. A student placed on social probation will be prohibited from attending or participating in any non-mandatory school function, activity or event. Non-mandatory school functions, activities or events include, **but are not limited to**:

- Attendance at school dances
- Attendance at athletic events
- Attendance at drama and musical productions
- Activities related to graduation, including the graduation ceremony.

### **Cell Phone Policy**

Cell phones and electronic devices may be used before and after school, during break/lunch and during passing times. Cell phones must NOT be out or in use at ANYTIME or ANYWHERE on campus during class time without permission from the teacher. If a cell phone is used during class time without permission, the student MUST surrender the phone to a staff member upon request. Students will then be able to pick up their phones from the main office at the end of the school day. Videos and pictures may not be taken during classes without teacher/staff permission. The following consequences will occur:

**First and Second Offenses:** Students may pick up their phone in the office at the end of the day and 2 hours of detention will be assigned.

**Third Offense:** Students may pick up their phone in the office at the end of the day and a Progressive Discipline will be assigned to the student.

**Fourth Offense:** Assistant Principal will contact parent or guardian then the phone will be returned at the end of the day and a Progressive Discipline will be assigned to the student.

**Continued Cell Phone Violations:** Will be treated as acts of defiance and will result in progressive discipline.

# Students who refuse to surrender their cell phone to a staff member will receive additional consequences for defiance.

#### Audio or Videotaping in Classrooms

Students or any other visiting adult who records in a classroom without the teacher and principal's permission violates Education Code section 51512. That section states: The Legislature finds that the use by any person, including a pupil, of any electronic listening or recording device in any classroom of the elementary and secondary schools without the prior consent of the teacher and the principal of the school given to promote an education purpose disrupts and impairs the teaching process and discipline in the elementary and secondary schools, and such use is prohibited. Any person, other than a pupil, who willfully violates this section shall be guilty of a misdemeanor. Any pupil violating this section shall be subject to appropriate disciplinary action.

#### **Extracurricular Activities Eligibility Requirements**

Students participating in extracurricular activities will meet existing state and local eligibility standards relating to the specific organization such as: California Interscholastic Federation (CIF), organization or club by-laws, and school district administration guidelines. These standards will not apply to scheduled classes, which include, as part of their curriculum, student participation in activities and performances outside of the regular classroom schedule required for grading purposes. Requirements for participation in all extracurricular activities will be as follows:

- 1. All ninth grade students shall be eligible to participate in extracurricular activities until their grades are reviewed at the end of the first quarter.
- 2. Students in grades 9 (other than first quarter) 10, 11, and 12 shall have a grade point average of C (2.0) at the quarterly grading period immediately preceding the activity in order to be eligible to participate in extracurricular activities.
- 3. A transfer student is eligible to participate if he/she was eligible at his/her previous school and is approved by CIF. Transfer students shall have one full grading period to meet the district eligibility requirements.
- 4. A student who leaves a team in mid-season without the coach's permission may be ineligible for another sport the following season.
- 5. In addition to academic requirements, students must complete all detention and have all fines paid:
  - a. At the beginning of each athletic season.
  - b. Prior to major activities: i.e. prom, graduation, and field trips.

The district shall provide an Eligibility Review Committee, which will consider appeals of the policy based upon a student's unique circumstances. The committee will have the authority to suspend the ineligibility rule if they determine "good cause" exists for such action.

Your coach/advisor will have a copy of the complete rules and regulations pertaining to the eligibility requirements.

**Please note:** Student Athletes must attend the majority of his/her school day on the day of contest or practice in order to participate (This includes R.O.P.). Athletes are expected to attend all classes and to be prompt. Unexcused absences from classes during the season may result in forfeiture of practice or athletic contest participation.

To Promote a respectful school culture that reinforces an inclusive and appropriate learning environment. Establish a safe learning environment in classes where protective or supportive clothing is needed. Allow students to wear comfortable clothing of their choice that expresses their self-identified gender. Allow students to wear religious attire without fear of discipline or discrimination. Prevent students from wearing clothing or accessories with offensive images or language (including profanity, hate speech, and pornography), that denote, suggest, display or reference alcohol, drugs, or related paraphernalia or other illegal conduct or activities, or that can reasonably be construed as being or including content that is racist, lewd, vulgar or obscene. Ensure that all students are treated equitably regardless of race, sex, gender identity, gender expression, sexual orientation, ethnicity, religion, cultural observance, household income or body type/size.

### **Dress Code Policy**

- Footwear must be worn at all times per state law.
- Backless and strapless tops are not permitted. Shirts/tops may not be see through; undergarments may not be exposed, and are not a substitute for clothing (any type of bras or boxers).
- Clothing must be worn in a way such that genitals, buttocks, and nipples are covered. Garments may not be sheer. Back and torso must be adequately covered.
- Clothing, jewelry, and personal items shall be free of writing, pictures or any other insignia which is vulgar, lewd, obscene, profane, or sexually suggestive or which promotes the use of drugs, alcohol, tobacco, or other illegal activity, including hate speech. No handcuffs and no pet collars are permitted.
- Wearing sunglasses is not permitted in the classrooms. No hoods on in the classroom, nor hats that cover the ears.

#### **Dress Code Enforcement**

Students shall be dress coded in private, one-on-one conversations or by use of an online referral form to respect the privacy and dignity of the individual. Dress code violations and referrals should take as little time away as possible from a student's instructional time. (Dress code violations and enforcement should not result in unnecessary barriers to school attendance). Students should not be shamed or required to display their body in front of others (students, parents, or staff) in school. "Shaming" includes, but is not limited to:

- Kneeling or bending over to check attire fit;
- Measuring straps or skirt/short length
- Asking student to account for their attire in the classroom or in hallways in front of others
- Call out students in spaces about perceived dress code violations in front of others.

1st Violation: Warning & Change of clothing

2nd Violation: Home contact & Change of clothing

3rd Violation: Home contact, Change of clothing, Detention

4th Violation: Home contact, Change of clothing, Saturday School

5th Violation: Mandatory parent meeting with Administration & parent



- Students must be in good standing including being free from any outstanding detentions and/or school fines. Students who are expelled, suspended, or on social probation are not eligible to attend school dances.
- Students must have their ID Cards to purchase a ticket.
- Tickets will not be sold at the door for any school dances.

### Dance Code of Conduct

- Student ID cards are required for entry into the dance (A digital ID card or a printed ID card is acceptable).
- Students MUST arrive no later than ONE hour after the dance has started. Once a student leaves the dance, he/she will not be re-admitted to the dance.
- School Dress Code is strictly enforced. Students who are in violation of the dress code will not be admitted.
- Students are expected to follow all school rules. Any student who is removed from the dance for any reason will lose the privilege of attending the next dance and parent/guardian will be called.
- No outside beverages or water bottles are permitted.
- No heels or black soled shoes that will scuff the gym floor are allowed to be worn on gym floor.
- Students may not bring purses, bags or backpacks into the dance.
- Each student will be searched upon entering the dance.
- Guests from other schools will only be admitted with a Guest Pass, a current photo ID and the name of the EDHS date. Guests are permitted to attend the following dances with admin approval: Homecoming and Prom.
- Students must be picked up no later than 15 minutes after the dance ends.
- Have fun and make responsible choices.

Unsafe, lewd, or vulgar dancing is not permitted. Students who are not dancing appropriately will receive a warning; a second offense will result in dismissal from the dance. The student will not be eligible to attend the next dance.
